Joining and donating the Jane Eakin Foundation, regulated by the 1901 law and which status are registered at the sub-prefecture in Apt, is to bring moral and financial support that consolidates the durability and the development of Jane Eakin's work. All members will be regularly informed of the incoming events in 2007.

All donators also benefit from an income tax deduction.

Indeed, August 2003 sponsorship law authorises associations that organize events and which management is non-commercial, to be able to collect donations.

The Jane Eakin Foundation is entirely managed by volunteers and all donations are entirely given to the Foundation. Consequently, this system allows private individuals to benefit from an income tax deduction that equals 66% of the donation amount, in the limit of 20% of the taxable income.
